

THE REVISION NOW SUGGESTED FOR PARAGRAPH 2 AS STATED IN YOUR TWX NO  
C-196 DATED JUNE 28 CMM 1960 CMM WOULD LEAVE US WITHOUT ANY GUARANTEE  
THAT WE WOULD GET ANYTHING BACK PD WE FEEL FURTHER THAT THE REVISION  
WOULD LEAVE US ENTIRELY AT DOD'S MERCY SUBJECT ONLY TO THE  
PERSUASIVENESS OF AEC PD APPROXIMATELY ONE MILLION DOLLARS IS INVOLVED  
HERE OF MATERIAL WHICH WE CONSIDER USEFUL ON FUTURE PROGRAMS PD WE  
STILL PREFER THE FORMER APPROACH THAT THE PROPERTY IS "RESERVED" FOR  
AEC CMM NOT "TRANSFERRED CMM" BUT AGREE THE TRANSFER DOCUMENT ITSELF  
SHOULD PROVIDE THAT THE AEC WILL NOT REMOVE ANY ITEMS ACTUALLY  
NECESSARY FOR THE MAINTENANCE AND OPERATION OF EPG BY PMR PD IT IS  
FURTHER CONSIDERED THAT IT WOULD NOT BE UNREALISTIC FOR THE DOD TO  
FURNISH AN ACCEPTABLE SUBSTITUTE BY PURCHASE OR FROM AVAILABLE DOD-  
STOCK IN THE CONTINENTAL UNITED STATES FOR ANY SUCH ITEMS PD  
WE APPRECIATE THE MANNER IN WHICH YOU HAVE PROTECTED OUR INTERESTS  
DURING THE CURRENT NEGOTIATIONS PD KNOWING THAT YOU WILL CONTINUE TO  
DO SO CMM AND IN VIEW OF THE TIME LIMITATIONS CMM IT IS NOW SUGGESTED  
THAT YOU PROCEED TO NEGOTIATE THE BEST TERMS POSSIBLE AND YOU ARE  
ASSURED THAT WE WILL BE PREPARED TO ABIDE WITH THE AGREEMENT REACH PD  
WE AGREE TO ACCEPT YOUR ADVICE AND THAT OF COL HOOD THAT WE SHOULD NOT  
TERMINATE THE AFFECTED PORTION OF CONTRACT AT/29-2/-20 UNTIL NOTIFIED  
THAT TRANSFER AGREEMENT HAS BEEN REACHED END REF TA CLN VWL-2583
