BIOGRAPHY

JAMES A. JOSEPH

The Honorable James A. Joseph was appointed Under Secretary of the Interior by President Jimmy Carter on March 14, 1977, following unanimous confirmation by the United States Senate

A former Vice President of Cummins Engine Company and President of Cummins Engine Foundation, he is the second highest ranking official in the Department of the Interior and; in the absence of the Secretary, serves as Secretary. The Department, with major responsibilities for the management of natural resources, the Administration of the American territories and Indian Affairs, has 70,000 employees.

Born in Opelousas, Louisiana in 1935, Mr. Joseph earned degrees from Southern University and Yale, and served as Commander of a Medical Detachment in the U.S. Army, before going on to college teaching and administrative positions in Alabama and California. An author, lecturer, university trustee and ordained minister, he has also had considerable experience in the Middle East, Europe, Latin America and Africa.

Mr. Joseph, who for three years hosted a television program for the NBC affiliate in Indianapolis, Indiana, is married and has two children.

BIOGRAPHY

Ruth G. Van Cleve

Mrs. Ruth G. Van Cleve is the Director of the Office of Territorial Affairs, Department of the Interior. Prior to her appointment in April 1977 to this position, she served with the Federal Power Commission, most recently as Assistant General Counsel. From April 1964 until March 1969 she served as Director of the Office of Territories, Department of the Interior. Immediately prior to that appointment, she was Assistant Solicitor in charge of the Branch of Territories in the Office of the Solicitor, Department of the Interior. She entered the Department on December 18, 1950, and from that date until April 1964 she devoted her efforts almost exclusively to the legal problems arising in the administration by the Department of the territories of the United States and the Trust Territory of the Pacific islands.

Born on July 28, 1925, in Minneapolis, Minnesota, Mrs. Van Cleve attended the University of Minnesota, received an A.B. degree in 1946, magna cum laude, from Mount Holyoke College and an LL.B. degree in 1950 from Yale University. Her academic achievements were recognized by membership in Phi Beta Kappa and prizes which she was awarded while at law school. She was awarded an LL.D. by Mount Holyoke College in 1976. During the academic year 1946-47, Mrs. Van Cleve was in Washington as an Intern in the National Institute of Public Affairs. Mrs. Van Cleve is a member of the District of Columbia and Minnesota Bars.

She serves as a Trustee of Mount Holyoke College. Her book, *The Office of Territorial Affairs*, was published by Praeger in 1974. Mrs. Van Cleve was a recipient of the Federal Woman's Award in 1966, the Interior Department's Distinguished Service Award in 1968, and the Federal Power Commission Meritorious Service Award in 1975.

With her husband, Harry R. Van Cleve, Jr., a member of the Renegotiation Board, Mrs. Van Cleve lives in Fairfax County, Virginia. Their children are John, just graduated from Washington and Jefferson College, Elizabeth, a student at Bowdoin College, and David, a student at Thomas Jefferson High School, Fairfax County.

VICE ADMIRAL ROBERT R. MONROE, U.S. NAVY
DIRECTOR, DEFENSE NUCLEAR AGENCY

Vice Admiral Monroe is the son of Mr. and Mrs. Robert A. Monroe of Knoxville, Tennessee. He enlisted in the Navy in 1945 as a seaman, and shortly thereafter began electronics training. In 1946 he entered the U.S. Naval Academy on a fleet appointment.

Graduating from Annapolis in 1950, Ensign Monroe spent his first four years at sea in the destroyers USS Forrest Royal (DD-372) and USS Strong (DD-758), where he served primarily in operations department billets. Both ships operated extensively in the Korean theater. From 1954 to 1956 he commanded the minesweeper USS Reedbird (MSC(0)-51) operating off the East Coast of the United States.

Lieutenant Monroe's first tour ashore, from 1956 to 1958, was in the Officer Planning Section of the Bureau of Naval Personnel in Washington. He returned to sea as Secondary Battery Officer and the Missile Officer of the cruiser USS Boston (CAG-1)-- then the world's only guided missile ship. After two years' postgraduate study at Stanford University, for which he received a Master's degree in International Relations, Lieutenant Commander Monroe in 1962 was ordered to the guided missile frigate USS Farragut (DLG-6) as Executive Officer.

From 1964 to 1966 Commander Monroe commanded the guided missile destroyer USS Charles F. Adams (DDG-2). During this period the ship operated frequently in the Mediterranean and Northern European waters, as had the previous two ships. He subsequently was assigned to the Office of the Assistant Secretary of Defense (Systems Analysis) in the Pentagon for a three-year tour.

In 1969 Captain Monroe placed the amphibious assault ship USS Juneau (LPD-10) in commission, and served as Commanding Officer through 1970, engaged in Southeast Asia operations. During 1971-72 he served in Washington as Executive Secretary of the CNO Executive Board.

Selected for promotion to Flag rank 1972, Rear Admiral Monroe was immediately assigned as Director of Systems Analysis for the Chief of Naval Operations, and served for a year in that billet. He went to sea as Commander, South Atlantic Force, U.S. Atlantic Fleet from 1973 until early 1974, commanding Task Force 86 throughout UNITAS XIV.

In 1974 he was assigned command of the Operational Test and Evaluation Force, the Navy's sole independent command for operational testing of new weapons systems--air, surface, sub-surface.

He was promoted to Vice Admiral and assumed command of the Defense Nuclear Agency on 1 April 1977.

Vice Admiral Monroe is married to the former Charlotte Anderson of Knoxville, Tennessee. They have three children-Bob (23), Nancy (21), and Susan (19). Bob is a 1976 graduate of the U.S. Naval Academy, currently assigned to USS Tattnell (DDG-19).
