Dear Kris:

This letter is to followup on the information I discussed with you on the phone regarding the June trip.

In setting up the schedule for the June voyage to Rongelap and Utirik, I would like to propose a few changes. First, I would like to extend the trip to Bikini. The inclusion of Bikini in the quarterly trips would be in support of the idea of dispensing general care to the people. In addition, the discovery of plutonium in urine specimens might require further studies. Second, I would like to extend the trip for a two week period. A proposed schedule is included with this letter. As can be seen it would allow two to three days at each island for examinations.

The purpose of the trip will be general health care evaluation of the people on the islands in support of the medical radiation program for Brookhaven National Laboratory. The care will be performed as follows:


1. general medical clinics
2. well baby clinics
3. immunization clinics
4. obstetric and family planning clinics
5. diabetic clinics
