Dear Mr. Hansen:

Enclosed is your Pan American ticket No. 56213, round trip from San Francisco. Pan American Flight 851 will depart from San Francisco International Airport at 11:00 a.m. on May 3, 1956 for arrival at Honolulu at 1:00 p.m. Local times are quoted. You have been assigned seat No. 10.

We will also find a written confirmation of your Garden View Single Room at the Royal Hawaiian Hotel in Honolulu for the period May 3 to May 5.

In accordance with our present plans, we are scheduled for departure from Hickam Field, Honolulu on May 5, 1956, Military Air Transport Service Flight 45 at 5:45 a.m., for scheduled arrival at Eniwetok at 1710. This is on a C-97 aircraft.

As you know, Pan American requests that all overseas flight travelers arrive at the departure terminal ticket counter one hour prior to departure time. Therefore, I suggest you plan to arrive at San Francisco International Airport at 10:00 a.m. on May 3rd. Please check to make certain that you carry your immunization/inoculation certificate on your person at all times. Without this certificate properly completed, immunization might be necessary at Hickam Field.

In addition to present plans, Dr. H. F. York, Director of the UCRL Livermore Laboratory, and Mr. James H. Corley, Vice President, Business Affairs, will also accompany us.

In the event of an emergency in your business or within your family, it is possible for us to reach you via teletype while you are in the Pacific Island Ground area. Should such an occasion arise, contact my assistant at Livermore, Mr. R. J. Patterson, or my secretary, Miss Sara Tiedemann, to determine the message that is to be sent. Either of these persons will see that the message is immediately dispatched.
