FOLLOWING A RECENT SPECIAL STUDY CONDUCTED IN THE MARSHALL ISLANDS AT THE REQUEST OF THE SURGEON GENERAL OF THE NAVY IT IS APPARENT THAT THE INFECTIOUS HEPATITIS EPIDEMIC ORIGINALLY REPORTED IN JUNE 1956 IS STILL SPORADICALLY ACTIVE IN CERTAIN AREAS OF THE MARSHALL ISLAND GROUP. AS THE RESULT OF THE FINDINGS OF THIS INVESTIGATION IT IS FURTHER CONCLUDED THAT THERE IS STILL A RISK TO THOSE PEOPLE WHO COME IN CONTACT WITH NATIVES, PARTICULARLY THOSE NATIVES UNDER 18 YEARS OF AGE. THIS RISK INCREASES WITH THE EXTENT OF CONTACT AND IS HIGHEST FOR PERSONNEL ACTUALLY LIVING ON ISLANDS INHABITED BY NATIVES. IN VIEW OF THE POSSIBLE LENGTHY INCUBATION PERIOD (UP TO CFN 1956 18
