MEMORANDUM FOR DEPUTY COMMANDER FOR AVIATION, CJTF-1:

Subj: Pilot and Monitor Training Over "Hot" Area.

1. This is a training project of the Radiological Safety Section in cooperation with USAF and USAE BUAFR - CROPSHAW operation. It was requested informally by Captain Lyon (IC), USAF, and has been the basis of dispatches from the Deputy Commander.

2. In response to Colonel Gandy's queries, the following is proposed:

(A) WHO?

All pilots and monitors likely to be in air operations zero plus 30 minutes, particularly F6F pilots.

Some pilots E17 are already at Roswell.

Monitors after 5 March at Los Alamos and can be available from there.

Among those are USAF and USA flight surgeons.

Navy pilots should be sent out if possible.

(B) WHERE?

Trinity, where 16 July test was fired. Based at Alamogordo Air Field. From some field other than Roswell. 5 cabs and crew already designated.

(C) WHEN?

As long as necessary for training. This to be decided by Captain Bolan (IC), AUS, and Dr. Harpalmann in conference with Radiological Safety Section, Headquarters CJTF-1 later. These individuals have charge of monitor training at Los Alamos.

(D) WHAT?

They would fly over Trinity, the "hot" site. They would experience Geiger counter reaction in plane. This would be:

- {a} Monitors
- {b} Pilots

Whatever additional training along this line deemed advisable.

Colonel Warren's idea of flashing bulb, etc., with goggles and blackened film has already been explained to Lt. Col. Talbot, who is enroute to Los Alamos.

(E) REPORT?

Weekly report of what was done and who did it to

- (a) Deputy Commander for Aviation, CJTF-1
- (b) General Rainey
- (c) Radiological Safety Section, Edgtrs, CJTF-1

(F) Single cub flown over "hot" area 27 February showed Geiger counters highly reactive.

(G) SECURITY.

Absolutely no mention of fact planes are taking this specific training or that test on 27 February was so successful until J-2 clearance is given, beyond essential participants. Gen. Groves has approved conduct of this training exercise. Details regarding local security to be worked out with Captain Nolan, Local MP's, Trinity must be advised, etc., also regarding newspaper leaks, etc.
