SUPPLEMENTAL AGREEMENT

THIS SUPPLEMENTAL AGREEMENT, entered into this 15th day of June, 1959, effective July 1, 1959, by and between the UNITED STATES ATOMIC ENERGY COMMISSION (hereinafter called "the Commission"), represented by the Commission's ALBUQUERQUE OPERATIONS (hereinafter called "ALO"), and the GOVERNMENT OF THE TRUST TERRITORY OF THE PACIFIC ISLANDS (hereinafter called the "Territory"),

WITNESSETH THAT:

WHEREAS, the parties hereto entered into Memorandum of Understanding No. AT(29-2)-613 for use of land under the control of, or to be secured by the Territory; and

WHEREAS, the parties desire to amend said Memorandum of Understanding No. AT(29-2)-613 is modified in the following particulars:

The term of said Memorandum of Understanding is hereby extended through June 30, 1959.

Total funds made available under this Agreement from its inception are increased by \$2,000.00 from \$10,000.00 to \$12,000.00.
