MORNING RADIATION SORTIE DELAYED BECAUSE OF POWER SUPPLY MALFUNCTION. TWO AND ONE HALF HOUR RADIATION MISSION FLOWN IN AFTERNOON COVERING BRUCE, BELLE, ALICE, KATE, NANCY, MARY, WILMA AND LUCY. HIGH ENERGY (50 KEV TO 3 MEV) PHASE ONE (PASSES PARALLEL TO LONGITUDINAL AXIS OF ISLAND AT ONE HUNDRED AND FIFTY FOOT SPACING) COVERAGE NOW COMPLETED ON EIGHTEEN ISLANDS. COMPUTER REDUCTION OF DATA PROCEEDING SMOOTHLY. SOME EXPERIMENTATION BEING DONE WITH SCALES AND PLOTTING TECHNIQUES TO TRANSLATE AERIAL RADIATION DATA INTO OPTIMUM WORKING OVERLAY DRAWINGS FOR THE ENGINEERING AND SOIL SURVEY GROUND PARTIES. ELMER AND IRENE COMPLETED WITH EXCELLENT RESULTS.
